1. Enter your enrollment number as your username and the password as given by the HOD
2. Dashboard of the student will open-up.
3. Click on fee details drop down menu.
4. Click on fee payment tab.
5. click on the year near the scholar number for which you are having the outstanding fee.
6. You will view your total fee payable.
7. Click on pay after selecting atom /billdesk
8. Payment Gateway asks about the type of transaction/name of the bank
9. Complete the transaction and print the receipt.
10. The successful payment will be reflected in your account details.
